Call to Order

District Parliamentarian, Distinguished Toastmaster Elizabeth Holland explained the voting procedures, election, and discussed the rules for the meeting.

Credentials Report

District Credentials Chair, Distinguished Toastmaster Iris Taylor, PDD presented the Credentials Report. There were 79 eligible clubs in the district, each club represents two votes, one for Club President, one for Vice President Education, for a total of 158 votes. To achieve a quorum, one-third of Club Presidents and Vice Presidents Education of eligible clubs must be checked in, which is 53. There are 28 Club Presidents and 35 Vice Presidents Education checked in. A quorum has been achieved, which is 63. There are also 18 District Executive Committee Members checked in, they do not count towards achieving a quorum, total ballots available are 81, if everyone votes, a simple majority would be 42 votes. District Credentials Chair, Distinguished Toastmaster Iris Taylor, PDD. moved that the report be adopted.

Answer:

District Alignment Chair, Distinguished Toastmaster Jenny Genser-White: FCC HQ has moved to northeast DC. The club will be going to District 36, starting July 1, 2023.

2 – District Leadership Committee Chair, Distinguished Toastmaster Bessie Johnson: In the report presented, one of the clubs within Division F shows up in two places.

Answer:

District Alignment Chair, Distinguished Toastmaster Jenny Genser-White: The duplication was due to a typo.

3 – Credentials Chair, Distinguished Toastmaster Iris Taylor: There are 10-11 clubs in Division D, instead of getting rid of the entire division could you have moved one of the virtual clubs into Division D, making it equal with Division B.

Answer: There weren't enough clubs to make both Division B and D viable. Division D was easier to split. Removing Division B would have been more difficult, the clubs would have to go into Division A because of their location.
